June 19...7:30PM Board Meeting 601 "D" Street

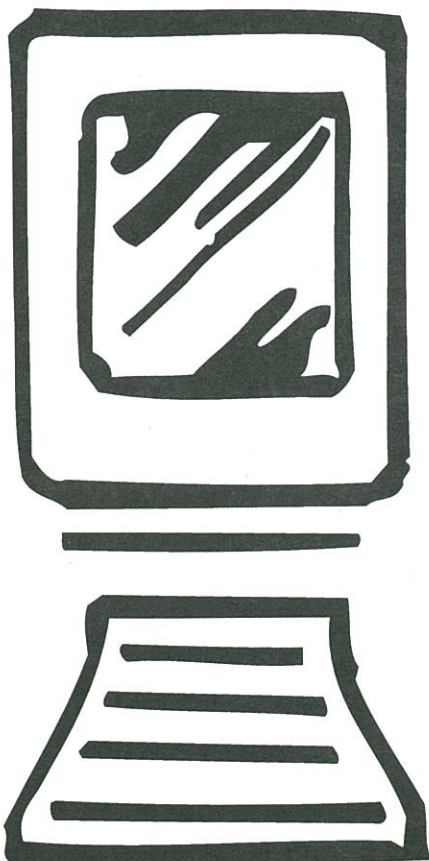
I want to invite you, our members, to come to the Heritage

BY-LAWS
of
The Lincoln, Nebraska Chapter
of the
AMERICAN HISTORICAL SOCIETY OF GERMANS FROM RUSSIA
Revised, April 17, 2006

ARTICLE I
Name

The name of this organization shall be the Lincoln, Nebraska Chapter of the American Historical Society of Germans from Russia.

ARTICLE II
Purpose

The purpose of this organization shall be to tell the story of:

1. The migration of our forefathers from Germany to Russia, and from Russia to North and South America.
2. The achievements of our people in the development of the United States, Canada, and countries of North and South America.
3. The religious faith of our fathers.

Further, the purpose shall be to do historical research and engage in the collection of items of historical interest.

ARTICLE III *
Membership and Dues

Section 1. Any Person who is a member of the American Historical Society of Germans from Russia and wishes to affiliate with the Lincoln, Nebraska Chapter is eligible for membership by paying the established Lincoln, Nebraska Chapter dues. Any person wishing to seek membership in the Lincoln, Nebraska Chapter as friends of A.H.S.G.R. may do so by paying the established annual dues of the Lincoln, Nebraska Chapter with the understanding that this membership does not include any privileges or benefits afforded to members of the American Historical Society of Germans from Russia.

*Revision

Section 2. Chapter dues may be established by a simple majority vote of Chapter members present at any of its meetings.

Section 3. Membership dues, if established, shall be based on the fiscal year of the Society and Chapter, January 1st through December 31st.

ARTICLE IV Officers

Section 1. The officers of the Chapter shall be a President, a First Vice-President, a Second Vice-President, a Recording Secretary, a Corresponding Secretary, a Treasurer, and an Historian, all of whom shall be elected at the Annual Meeting of the Chapter. The directors may from time to time designate and elect such additional officers as they shall find necessary or proper for the promotion of the Chapter.

Section 2. Officers shall be elected annually and serve for one year or until their successor is elected and may not serve for more than three consecutive terms in the same office.

Section 3. The President shall have executive supervision over the activities of the Chapter within the scope of these Bylaws.

The President shall:

1. preside at all meetings of the Chapter and of the Board of Directors.
2. report annually on the activities of the Chapter
3. appoint committee members and delegates not otherwise provided for, subject to the Board of Directors' confirmation.
4. fill vacancies among the officers, contingent upon confirmation by the Board of Directors.

Section 4. The First Vice-President shall assume the duties of the President in the event of the absence, incapability, or the resignation of the President. Also, the First Vice-President shall be responsible for the programs at Chapter meetings and shall perform such other duties which may be assigned to him/her by the President of the Board.

Section 5. The Second Vice-President shall assume the duties of the First Vice-President in the event of absence, incapability or resignation of the First Vice-President. Also, he/she shall be responsible for the recruitment and maintenance of membership.

Section 6. The Recording Secretary shall keep the minutes of the meetings of the Chapter and the Board of Directors.

Section 7. The Corresponding Secretary shall conduct all correspondence as directed by the President and the Board of Directors.

Section 8. The Treasurer shall be responsible for the safekeeping of Chapter funds and for maintaining adequate financial records. The Treasurer shall deposit all monies received for the Chapter in a checking account in a bank regularly selected by the Board of Directors. Monies shall be disbursed by the Treasurer as directed by the Board of Directors. The Treasurer shall make a report to the Chapter at the annual meeting and to the Board of Directors at all regularly scheduled meetings.

Section 9. The Historian shall keep a record of the historical development and progress of the Chapter.

ARTICLE V Meetings

Section 1. A minimum of four regular meetings of the Chapter shall be held annually, time and place to be determined by the Board of Directors of the Chapter. One of these meetings shall be held the second Sunday in January and shall be designated as the Annual Meeting.

Section 2. The purposes of Chapter meetings shall be for social contact, the transaction of Chapter business, and to foster the goals of the American Historical Society of Germans from Russia.

Section 3. Special meetings of the Chapter may be called by the President or by any three members of the Board of Directors or by the Secretary on receipt of a petition signed by at least one-fourth of the regular members.

Section 4. Twenty-five members of the Chapter in attendance at a regularly scheduled meeting of the Chapter shall constitute a quorum.

Section 5. Notice of meetings shall be mailed to all members at least ten days prior to scheduled meetings.

ARTICLE VI Board of Directors

Section 1. A Board of Directors consisting of no fewer than 12 and no more than 18 members shall be elected for the term of three years - one third of whom shall be elected annually at the Annual Meeting of the membership.

Section 2. The immediate past President shall be a member of the Board of Directors with voting status.

Section 3. The Board of Directors shall have the power to conduct the affairs of the Chapter. The Board shall decide questions of policy that for any reason cannot be acted upon at a meeting of the Chapter, and perform such other functions provided for in these committees as it may deem necessary or appropriate.

Section 4. The Board of Directors of the Chapter shall meet at least quarterly. Additional meetings may be called by the President or at the request of any three Board members.

Section 5. At any scheduled meeting of the Board of Directors, 8 members shall constitute a quorum for the conduct of business.

Section 6. Any Board member who misses three consecutive meetings without an adequate excuse shall be automatically dropped from the Board. The President is to compose a letter to be approved by the board to send to such a Board member notifying him or her that he or she will be automatically dropped from the Board in 30 days from the date of the letter unless said Board Member contacts the President or the Recording Secretary in writing requesting a hearing by the Board.

ARTICLE VII Committees

Section 1. The following committee Chairmen shall be appointed by the President, subject to approval by the Board of Directors: Membership, Publicity, Program, Genealogy, Finance, Nominating, and Social.

Section 2. The Membership Committee shall seek methods of locating persons eligible for membership in the Chapter and Society. It shall encourage active participation of all members in the activities of the Chapter. It shall perform required duties in cooperation with the Second Vice-President.

Section 3. The Publicity Committee shall give to the public, through all news media or other means, publicity regarding the Chapter and Society, its purposes and its activities.

Section 4. The Program Committee shall arrange suitable programs for meetings of the Chapter, when appropriate drawing upon sources of art, music, and other folklore of the Germans from Russia.

Section 5. The Genealogy Committee shall collect genealogies of Germans from Russia and grant assistance to members of the Chapter and Society searching for sources of information regarding ancestral background.

Section 6. The Finance Committee shall: Provide ways and means of fund raising and arrange for the annual audit of the Chapter accounts.

Section 7. The Nominating Committee shall present to the Chapter membership annually a slate of nominees from the membership for members of the Board of Directors and officers. This slate shall be brought before the annual meeting of the chapter for vote. Additional nominations may be named from the floor. Prior approval to serve actively must have been secured from the nominee.

Section 8. The Social Committee shall set up refreshments when appropriate and clean up. They shall make sure arrangements for any refreshments are made.

Section 9. Other committees, standing or special, may be appointed by the President as needed with the approval of the Board of Directors.

ARTICLE VIII Amendment of Bylaws

Section 1. All Bylaws of the Chapter shall be subject to alteration, amendment or repeal, and new Bylaws may be added by a majority of the members of the Board of Directors at any regular or special meeting after having been presented to the Board members at their previous meeting.

Section 2. These Bylaws may be amended, substituted or superseded by action of the members of the Chapter at any annual meeting provided that such action shall have been presented to the Board of Directors in writing not later than sixty (60) days prior to the said annual meeting.

ARTICLE IX Parliamentary Authority

The rules contained in the current edition of Robert's Rules of Order Newly Revised, or other authority on Parliamentary Procedure designated by the Board of Directors of the Chapter shall govern the proceedings of the Chapter except in such cases as are governed by these Bylaws.
